By signing this consent form, I agree that all of the Materials may be delivered to me electronically and recognize that not all Materials will be available electronically immediately but that electronic delivery will develop over time.

I agree to regularly check the Fund's section of the Manager's website at www.growthworks.ca for Materials and if you place Materials on your website for viewing, printing or downloading, that will satisfy your delivery obligations. If Materials are placed on your website, they will be available for viewing until the meeting date in the case of proxy materials and for at least 12 months in the case of all other Materials.

In addition, you may decide to send me an electronic mail (or email) attaching the Materials or notifying me that Materials are available for electronic delivery and providing details as to the delivery process. In the case of Materials containing personal information, I acknowledge that you will take steps to ensure that I am the only person that receives them.

3. I understand that you will not disclose my e-mail address or other contact information to any third party unless it is necessary by law, required to effect the delivery of the Materials, or in accordance with your use of personal information policy.
4. Materials will be in Adobe Acrobat format and will require me to have a computer that has an Internet "browser" (such as Microsoft Internet Explorer) that is able to run Adobe Acrobat Reader version 5.0 or higher. *Adobe Acrobat Reader 5.0 is available free of charge at www.adobe.com.*
5. I understand that I will be provided with a paper copy of any Materials at the address on file for me if you receive notice that electronic delivery has failed. I acknowledge that I can receive a paper copy of any Materials at no cost if I contact you by telephone, regular mail or email at addresses listed on the Manager's website at www.growthworks.ca.
6. I understand that my consent may be revoked or changed, including any change in my email address at any time, by notifying you of such revision or revocation by telephone, regular mail or email at addresses listed on the Fund's section of the Manager's website.
